**COMMUNITY CENTRE RULES**

---

**SQUASH, RACQUETBALL AND WALLYBALL COURT RULES**

- A. Court bookings are 45 minutes in duration.
- B. Maximum of two consecutive court reservations.
- C. Proper "non-marking" footwear must be worn. No street shoes are allowed.
- D. Recreation Members have the privilege of reserving a court 2 days in advance. Non-members can only reserve a court on the same day.
- E. Protective eyewear is mandatory for persons playing squash or racquetball.
- F. All person(s) using the courts must check in and check out at the Recreation Office.

**FITNESS ROOM**

- A. Weights are to be put away after use.
- B. Dropping weights is prohibited.
- C. Fitness Room Door is to be closed at all times.
- D. No outdoor shoes are allowed.
- E. Fitness Room maximum occupancy - **20**
- F. T-shirts must be worn when lying or sitting on benches.
- G. Fitness Room Music System is located in the Community Centre Office. Volume level and music channels will be controlled by the Office Staff. Only personal headsets will be allowed. Users are not allowed to bring in their own personal devices to play out loud.
- H. *Fitness Room age limit is 13 years old. (Revised Jan.2016)*
- I. No personal exercise equipment is allowed in the Fitness Room.

**TENNIS COURT RULES**

- A. No formal court bookings required. Please limit your court time to 60 minutes, if there is a demand for the courts out of courtesy to others
- B. Proper footwear is mandatory.
- C. No Skateboards allowed on the Tennis Courts

**RECREATION FACILITY RULES**

- A. These rules apply to all persons in all facilities and programs under the control of the Terrace Bay Recreation Department.
- B. The use of improper, profane, obscene or abusive language is not permitted.
- C. Courtesy and respect is expected to be shown to others and to property at all times.
- D. Litter is to be disposed of in a proper waste receptacle.

- E. Possession of illegal or unauthorized drugs is not permitted.
- F. Liquor is not permitted, except under the authority of a proper licence issued by the Liquor Licence Board of Ontario.
- G. All accidents involving personal injury or damage to property are to be reported to the Recreation Office or Recreation Staff immediately.
- H. All damaged or mal-functioning equipment is to be reported to the Recreation Office or Recreation Staff, by completing a proper Work Order Form, located in the Recreation Office.
- I. The Recreation Department will not be responsible for any lost or stolen articles.

## **CODE OF BEHAVIOUR**

---

### **REASONS FOR CODE OF BEHAVIOUR**

- A. To promote the public use and enjoyment of community recreation facilities and programs
- B. To minimize the cost of maintenance of community recreation facilities due to vandalism
- C. To provide for the safe and orderly conduct of recreation programs without interruption
- D. To make users aware of the responsibilities which accompany their rights to the use of community recreation facilities and programs
- E. To prevent occurrence of inappropriate behaviour in community recreation facilities and programs
- F. To deal with incidents of inappropriate behaviour

### **RULES OF BEHAVIOUR**

1. These rules apply to all persons in all facilities and programs, under the control of the Terrace Bay Recreation Department.
2. The use of improper, profane, obscene or abusive language is not permitted.
3. Courtesy and respect is expected to be shown to other and to property at all times.
4. Litter is to be disposed of in proper waste receptacles.
5. Possession of illegal or unauthorized drugs is not permitted.
6. Liquor is not permitted, except under the authority of a proper license issued by the Liquor License Board of Ontario.
7. All accidents involving personal injury or damage to property are to be reported to the Recreation Office or Recreation Staff immediately.
8. All damaged or malfunctioning equipment is to be reported to the recreation office or recreation staff by completing a proper work order form, located in the recreation office.
9. The Terrace Bay Recreation Centre is not responsible for any loss or stolen property.

## **DISCIPLINARY ACTIONS**

Failure to abide by these rules of behaviour may result in disciplinary action by the Corporation of the Township of Terrace Bay. Examples of disciplinary measures which may be applied are:

- A. Suspension of the offender's right of access to all municipal recreation facilities in accordance with the Trespass to Property Act.
- B. Suspension of the offender's participation in any or all municipal programs of recreation.
- C. Recommendation to user groups that the offender be prohibited from or restricted in participation in their facilities.
- D. Referral of the incident to the police or courts.

**Cooperation of all persons with the above Code of Behaviour is appreciated by the Community**
